What is EBALDC's 48th Anniversary Gala Celebration?	This is EBALDC's annual fundraiser that brings together 400 people to recognize the contributions of our honorees and support EBALDC.
When and where is the gala taking place?	Thursday, September 7, 2023, 5:30pm <b>Preservation Park</b> <b>1233 Preservation Park Way (Entrance on Martin Luther King Jr. Way between 12<sup>th</sup> &amp; 14<sup>th</sup> Streets)</b> <b>Oakland</b>
Is parking available at the venue?	City Center West Garage <b>1250 Martin Luther King Jr. Way</b>
Will there be validation for parking?	Yes! You <b>MUST</b> download <b>ParkMobile App</b> . Create an account if you don't already have one. <b>DO NOT "Continue As A Guest" (You will not be able to use Validation Code)</b> After setting up an account, find <b>Zone 65361</b> 1. Add your parking duration. 2. Add your vehicle information 3. Enter the following validation code in the promocode section: <b>PPEBALDC48</b>
Is there bike parking?	Yes, there are bike racks along the side walk at Preservation Park where you can lock up your bike

What to expect from the event?	EBALDC's Gala kicks off the fall fundraising season, with an evening of networking, recognizing our honorees' accomplishments, and raising much-needed funds for EBALDC to realize its vision of an East Bay where everyone has a place to call home and the resources to thrive
Will there be a seated dinner or buffet-style meal?	The event is a reception-style event with a buffet style meal and beverages
Are there any special dietary options available?	We will select menu items so that all guests will have generous food options.
Will there be a cash bar or open bar?	Open Bar!
<b>Questions RE: Fundraising and Donations</b>	<b>Answers</b>
Will there be any fundraising activities during the event?	Yes. We will have a Fund-A-Need that will support EBALDC's Economic Opportunities department. Our low-income neighbors are still struggling to recover from the pandemic, especially with increased housing costs and inflation. EBALDC's Volunteer Income Tax Assistance (VITA) program returns nearly \$2MM back to our communities. Our 1:1 Financial Coaching program through SparkPoint Oakland helps clients realize their financial health goals, including opening a bank account and attaining good credit. In addition, the Bay Area Mural Program (BAMP) will "perform" an audience-engaged live drawing during the gala. The final art piece (measuring 4'x4') will be auctioned off.
